



CALL TO ARTISTS

THEME: *"Beyond the ordinary,"* evocatively passionate, surreal fantasy, unbridled taboo erotica.

REGISTRATION: pre-registration \$15, due by January 24, either postal mail or email dana@alwunhouse.org. Registration \$25 at art delivery Saturday & Sunday, February 1 - 2 (Alwun House members \$15*). Include artist bio, no more than two pages. Price artworks to include 25% commission to Alwun House. All sales conducted through Alwun House Foundation.

IMAGES: Submit up to three jpgs for inclusion in exhibit publicity: dana@alwunhouse.org (300 dpi, approx 4"x 6" jpg's). We print and distribute 5,000 color invites, 10,000 e-notices, and posters.

Art Delivery | Acceptance: Nov. 30 - Dec. 1, Sat - Sun, 11am - 5pm. Submit: up to 3 pieces. All work must be structurally and mechanically sound, and arrive ready to hang or display. Works will be reviewed for acceptance at time of delivery. Accepted works will then be presented to jury for awards. Artist responsible for model releases if applicable. Price to include 25% commission to Alwun House.

Exotic Artists Benefits: House policy gives exhibiting artist, complimentary entry to opening event, Friday Feb. 14, 2020. Artists and a guest comp at Erotic Poetry & Music Festivus, Friday Feb 21, and at Closing event (March 21). Free viewing for artist and guest during regular galley hours.

Juror Awards: Three \$1,000 *"Critic's Choice"* awards announced Feb 14, "People's Choice" \$200 award announced at closing event March 21, 2020.

Art Pick-Up: Sunday & Monday; March 22 & 23, 12-5pm. Work left after March 23, assessed \$3 storage fee per day, per piece (unless prior arrangement made). Art left more than one month (April 23, 2020) is subject to sale or disposal without further notice.
